Sir,

The National Judicial Academy (NJA) is the premier Institution in India imparting judicial education to the Judges of the Indian Judiciary. The NJA is guided and administered by the puisne justices of the Supreme Court of India and Hon'ble the Chief Justice of India is the Chairman of the National Judicial Academy.

The vision of the NJA is Judicial Education enhances the timely delivery of justice. NJA views continuing education as a process of "creating solutions" and judicial education as a process of "creating solutions for strengthening the administration of justice. Judicial education at the NJA brings together judges from across the country to provide them a forum to jointly identify the major obstacles facing the administration of justice and develop appropriate solutions for overcoming these obstacles.

To assist in this process, NJA will identify priority challenges facing the administration of justice and organize appropriate programs to facilitate problem solving. NJA will assemble knowledge inputs (documentary as well as experts) and new ideas that will assist judges in problem solving.

NJA also conducts programs for judges of other countries which are sponsored under ITEC arrangement with the Ministry of External Affairs. As of now, programs have been confirmed for Bangladesh and Maldives. These programs mainly concentrate as to the better governances adopted by the Indian Judiciary and the general principles of the Indian laws and jurisprudence.

The programs of the National Judicial Academy are likely to commence from the month of September, 2021 and continue till April, 2022. As of now, programs shall be online and when Covid protocols permit, physical meetings also shall commence.

NJA has a panel of Justices of the Supreme Court of India, High Courts and distinguished academicians and faculties as Resource Persons. This panel is updated annually. As the academic programs are to commence shortly, NJA is now in the process of updating the panel of the resource persons.
