
Sub - Panel of Advocates to handle the 24 hour Mobile Help Line
No.9846700100 of KeLSA - applications invited - reg

The Kerala State Legal Services Authority provides a 24 hour toll free legal helpline services with toll free No.9846700100 from 2006 onwards to provide legal assistance to the citizens in distress. The help line of KeLSA is now linked to 15100, the National Legal Aid Help line of NALSA. The mobile telephone handset is handled by a legal professional who can be accessed around the clock.

The Hon'ble Executive Chairman, KeLSA by order dated 13.09.2022 has approved to constitute a new panel of lawyers for handling the 24 hour toll free help line of KeLSA by inviting applications from lawyers with a minimum of 5 years active practice and practicing in the High Court and at the District Centre, Ernakulam. The service of the lawyers will be utilized on monthly rotation basis. The existing payment of honorarium is at the rate of Rs 500/-per week. A proposal for enhancing the honorarium to the rate of Rs 3000/-week is pending sanction of the Government.

Applications are invited in the enclosed format from Advocates who are desirous of being included in the panel of lawyers for handling the 24 hour toll free help line of KeLSA. A self attested copy of enrolment certificate and the certificate of active practice issued by the Bar association concerned shall be attached along with the application.

The application addressed to the Member Secretary, Kerala State Legal Services Authority, Niyama Sahaya Bhavan, High Court Compound, Ernakulam, shall reach in this office on or before **28.09.2022**.
