### **NOTIFICATION [KHCAC-P-VI/2025]**

This notification is for the empanelment of Arbitrators to Panel VI (Experts' Panel) of the Kerala High Court Arbitration Centre (KHCAC). Applications in the prescribed format are invited from the eligible and qualified professionals to be empanelled as Arbitrators to Panel VI of KHCAC.

The last date for submitting the application before the KHCAC is 09/01/2026 (upto 4:30 pm).

- **I. Qualifications:** The candidate for empanelment as Arbitrator to Panel- VI shall satisfy the following conditions, namely-
  - Shall be a qualified professional with specialized knowledge in any of the industries or branches of trade specified in Annexure-A;
  - Shall hold a degree or higher qualification in the relevant subject, along with a minimum of ten years of experience in the corresponding field of expertise;
  - Shall be of good character;
  - Shall be of sound health free from any bodily infirmity that renders him unfit for appointment as an Arbitrator; and
  - Shall also fulfill the eligibility and other norms mentioned in this notification.

- **II.** <u>Disqualifications</u>: The following persons shall be deemed to be not eligible to apply for empanelment as Arbitrator:
- he has applied to be adjudged as insolvent or has been adjudicated insolvent;
- he is declared to be of unsound mind or has become incapacitated;
- criminal charges involving moral turpitude have been framed against the person by a criminal court and are pending;
- he has been convicted by a court for an offence involving moral turpitude;
- disciplinary proceedings or charges related to moral turpitude have been initiated against against him by the appropriate disciplinary authority and are either pending or have resulted in a punishment;

### III. Submission of Applications:

- 1. The applicant shall pay the application fee of Rs.1000/- to the Savings Bank account number 43828249866, IFSC SBIN0010564, High Court of Kerala Branch, Ernakulam of the KHCAC. The payment receipt must be submitted along with the application. Applications that do not include the receipt of the application fee payment will be rejected. The application fee is non refundable.
- 2. The applications should be sent to the following address:

The envelope containing the application must be labeled as "Application for Empanelment as Arbitrator to Panel-VI". The applicant's full and correct address must be clearly stated in the "From" address section on the envelope.

- 3. The candidates shall also forward copies of the following documents with their application:
- (a) Document to prove the date of Birth.
  - (b) Certificate to prove the educational qualifications.
  - (c) Certificate or other document to prove their experience in corresponding field of expertise;
  - (d) List of cases conducted as an arbitrator (if any).
  - (e) Copy of two awards in contested arbitration cases, preferably issued within the last two years by the candidate, (if any), in which the applicant was an expert.
  - 4. The candidate shall produce the original of the documents as and when required by the KHCAC.
  - 5. The last date for submitting the application before the office of KHCAC, is 09.01.2026.

### IV. The process of empanelment:

- 1. Before presenting the application, the applicants shall ensure their eligibility according to the criteria stipulated in the notification. Full and correct information shall be furnished in the application. Furnishing of false or incorrect information or suppression of material information will disqualify the candidate at any stage of the process. Anything not specifically disclosed in the application against the appropriate field will not be considered at a later stage. Incomplete applications or applications submitted not in accordance with the eligibility and other norms mentioned in this notification, will be summarily rejected.
  - 2. KHCAC shall adopt an appropriate selection process such as interview, interaction, written test, or any other suitable method to identify and empanel eligible and suitable candidates.

- 3. If any applicant is found ineligible or has committed malpractice at any stage of the process of empanelment, such candidature shall be canceled.
- 4. The communications will be sent to the applicant by email or WhatsApp number furnished in the application.
- 5. **KHCAC** will not be responsible for loss of communications due to the wrong email IDs or WhatsApp number provided by the candidate.
  - 6. No candidate shall submit more than one application in response to this notification.
  - 7. In the event of any inadvertent error identified at any stage of the empanelment process, even after the publication of the final list of candidates for empanelment, the KHCAC reserves the right to modify, withdraw, or cancel the empanelment of such candidates and will notify them accordingly.
  - 8. KHCAC reserves its right to modify or cancel this notification at any stage of the process without assigning any reason. Decision of the Council or Board of Governors, KHCAC in all matters regarding the empanelment would be final and binding on all candidates. No representation or correspondence will be entertained in this regard.
- 9. The candidates approved by the Board of Governors of the KHCAC, will be empanelled. The final list of the candidates who successfully completed the process of empanelment will be published in the website of KHCAC.
  - 10. The decision of the Council/Board of Governors of KHCAC regarding the process of empanelment shall be final.
  - 11. All applicants, upon being empanelled, shall adhere to the Kerala High Court Arbitration Centre Rules, 2025, decisions of the Council and Board of Governors

regarding their empanelment, performance, code of conduct, ethical standards, removal from the panel, and any other guidelines issued by the Board or Council.
