

NOTICE

Members of this Association who are interested in assisting this Hon'ble Court as Amicus Curiae in various matters pending adjudication before it are invited to submit their willingness for empanelment. A category-wise panel of willing Advocates is proposed to be constituted based on standing at the Bar, for being placed before this Hon'ble Court and drawn upon as and when the occasion arises.

Applications are invited under the following categories, determined with reference to the applicant's total years of practice as on the date of this notice. Those members whose years of practice are close to reaching the next ceiling limit (within 3 months) can opt for the next category.

Category	Standing at the Bar	Basis
A	2 years and above, up to and including 5 years	Total practice
B	Above 5 years, up to and including 10 years	Total practice
C	Above 10 years, up to and including 20 years	Total practice
D	Above 20 years	Total practice

*Standing at the bar:- Total years since KHCAA membership

Members belonging to Categories C and D (i.e., those with more than 10 years of standing) shall additionally furnish their fields of experience/expertise in the biodata proforma, to enable subject-wise matching of amicus assignments. This is not required for Categories A and B.

Interested members may submit the duly filled-in biodata proforma (Annexure-I) enclosed herewith, together with self-attested copies of the Enrollment Certificate and KHCAA membership card, to the Office of the Association or by e-mail to k.hcaa@yahoo.com, on or before 14.08.2026, 5PM.

The panel so constituted shall be maintained by the Association and forwarded for the consideration of the Hon'ble High Court, and names may be recommended therefrom in respective capacities in matters requiring such assistance, at the discretion of the Court.
